## Description of Palliative Services

**Oklahoma Palliative & Hospice Care's** palliative program provides individualized care for seniors with serious illnesses, who are experiencing some or all of the following:



- ◆ **Seeking** relief from severe chronic illnesses with symptoms such as pain, shortness of air and anxiety.
- ◆ **Needing** complex care, as the result of multiple diseases, requiring difficult and complex decisions to be made
- ◆ **Requiring** many medications for disease and symptom control
- ◆ **Suffering** from low quality of life for both the patient and the family
- ◆ **Receiving** care from multiple health care professionals
- ◆ **Experiencing** frequent health care episodes resulting in emergency hospitalizations or additional treatment
- ◆ **Obtaining** curative treatment but also needing additional assistance
